### A Dialogue promoted by the Italian Presidency 2013-2014 of the Alpine Convention

*PIEVE DI CADORE (BL), Italy - 12th SEPTTEMBER 2014 – 9 AM - 2:00 PM*

The Italian Ministry for the Environment, in cooperation with the Veneto Region and the Magnifica Comunità di Cadore, organize a public scientific Workshop in the framework of the Italian Presidency 2013-2014 of the Alpine Convention on the topic of *“The services of the Alpine forests ecosystems as a natural, economic and cultural asset for a regional and European green economy”*. The event will take place on 12th September 2014 in Pieve di Cadore (Belluno, Italy), on the premises of the headquarters of the “Magnifica Comunità di Cadore”

The Workshop has the objective to foster a public dialogue between the local, national and international institutions, the academic environment and other relevant stakeholders coming from multiple sectors and on the methods, good practices and existing specific approaches for the valorization of the Alpine forests and of the multiple environmental, economic and social services guaranteed by the multi-functionality performed by mountain forests ecosystems.

The Workshop is organized in the framework of the public institutional and scientific events promoted by the Italian Ministry for the Environment with the Alpine territorial institutions during the Italian Presidency 2013-2014 of the Alpine Convention, the first international treaty dedicated to the protection and sustainable development of a cross-boundary mountain territory which was signed in 1991 by the eight Alpine Countries and by the EU. On initiative of Italy, the Ministers of the Alpine Convention established an international Working Group on the topic of “Mountain Forests” at the XII Alpine Conference (Poschiavo, 6-7 September 2012).

During **the first part of the Workshop**, international, national and local technical experts and institutional representatives will contribute to the works and results of the Working Group “Mountain Forests” of the Alpine Convention in order to **analyse the main recent insights in the territorial, EU, and international policies for the development of the Alpine forest sector**. A specific focus will be dedicated to the existing methodological approaches and concrete practices oriented to the implementation of strategies aimed to the valorization and sustainable management of forest resources and of the multifunctionality of forests’ ecosystem services, to reason about the perspectives for a contribution of the Alpine forest sector in a regional and EU green economy .
